

[Accommodation Rules and Agreement for Stays with Pet]

Enacted: Jan 01, 2022

In order to ensure that all guests can enjoy a comfortable stay at our facility when staying with pets (dogs), I agree to adhere to the following terms. (This agreement applies to pets other than service dogs.)

Accommodation Conditions

- Pets (dogs) that can accompany guests must be small indoor dogs that are at least six months old, weigh less than 8 kg, are not undergoing treatment for illness or injury, have basic training, can sleep in a cage at night, and do not bark excessively, jump on people, mark territory, or damage the facility.
- Staying with a pet (dog) is allowed only if you have booked the "Pet-Friendly Plan," and only one dog is permitted per designated room.
- The pet (dog) must meet the legal requirements for vaccinations (such as the Rabies Prevention Act) and must also be vaccinated against viral infectious diseases.
- Please be sure to bring a copy of the rabies vaccination certificate and the proof of vaccination for viral infectious diseases, as we will check them at the time of check-in.
- For female dogs, they must not be in heat (at least 4 weeks have passed since the start of their menstruation cycle), not be pregnant, and not currently be in their menstruation period.
 Additionally, the dog must not be expected to be in their menstruation during the stay.
- Please ensure that your pet has been treated for fleas and ticks.

♦Important Notes for Use

- Our facility is not exclusively for pets. As there are guests who may not be comfortable around pets, we kindly ask that you ensure your pet does not bark unnecessarily. If excessive barking continues, you may be asked to move your dog to your vehicle.
- Please ensure that your pet is in a travel cage or travel crate when moving around the facility outside of your room. Carrying your pet in your arms is not allowed.
- Your pet can only accompany you in the designated pet-friendly rooms. Outside of your room, your pet is not allowed in other areas used by other guests, such as the lobby, restaurant, shop, or

public baths. Additionally, pets are not permitted to enter any other rooms besides the designated pet-friendly ones.

- Please refrain from leaving your dog alone in the room for a long time.
- We are unable to provide any pet-sitting services at our facility.
- We provide special amenities for your pet, including a dog playpen, food bowl, toilet tray, mat & sheet, trash bin, lint roller, and wet wipes. However, we do not provide pet food, toys, or bedding (such as blankets or towels). Please bring these items with you.
- Please do not allow your pet to be on the bedding or the table.
- Please refrain from brushing your pet.
- Please be careful not to cause any damage to the building, furniture, equipment, amenities, or other facilities. You will be responsible for any repair costs resulting from damage or soiling caused by your pet. In case of any damage or issues, please contact the front desk immediately.
- Please clean your pet's feet before entering into the room.
- Please bring any emergency medication for your pet with you.
- Notes
- If there is any false information in your application or if you do not comply with the terms of agreement, or if you violate the terms of use and cause significant inconvenience, danger, or accidents to other guests, we may refuse accommodation with pets. Please be aware of this in advance.
- While we will do our best to accommodate your pet, the facility will not be held responsible for any injuries, escape, or death resulting from irresistible forces. We are also not liable for any associated compensation. Similarly, we will not be responsible for any troubles between guests or between pets that arise due to the presence of your pet.
- If any damage is caused to the facility, other guests, employees, or third parties due to your pet, you will be required to compensate for the damages.
- Please be aware that the designated pet-friendly rooms are used by pets. If you develop any animal allergies or other health issues, you are responsible for addressing them, and the facility will not be liable.
